G.D.G. Software SAS END-USER LICENSE AGREEMENT FOR EXECUTPUT FOR PHP

IMPORTANT - READ CAREFULLY

This license statement and limited warranty constitutes a legal agreement ("License Agreement") between you (either as an individual or a single entity) and G.D.G. Software SAS ("G.D.G. Software") for the software product named "ExeOutput for PHP" ("Software Product"), including any software, media, and related on-line, printed or electronic documentation.

By installing, copying, or otherwise using the Software Product, you agree to be bound by the terms of this License Agreement. If you do not agree to the terms of this License Agreement, do not install, copy, or use the Software Product.

This license agreement shall supersede any verbal, or prior verbal or written, statement or agreement to the contrary.

1. OWNERSHIP

The Software Product is proprietary to G.D.G. Software. The Software Product is licensed, not sold, to you notwithstanding any reference herein to "purchases." You acknowledge and agree that: (a) the Product is protected under copyright laws and international copyright treaty; (b) G.D.G. Software retains all copyrights and other intellectual property rights in the Software Product; (c) there are no implied licenses under this License, and any rights not expressly granted to you hereunder are reserved by G.D.G. Software; (d) you acquire no ownership or other interest (other than your license rights) in or to the Software Product; and (e) G.D.G. Software owns all copies of the Software Product, however made. You agree that you will not, at any time, contest anywhere in the world G.D.G. Software's ownership of the Software Product, nor will you challenge the validity of G.D.G. Software's rights in the Software Product.

2. NO WARRANTLY

This Software Product and/or related documentation and files are provided on an "as is" basis, without any representation or warranty of any kind, either express or implied, including without limitation any representations or endorsements regarding the use of, the results of, or performance of the Software Product, its appropriateness, accuracy, reliability, or correctness.
